The current methods are not accurate enough and require resources to initiate, store, and analyze.

- **Temperature screening** can only detect those with active symptoms and can miss those who are asymptomatic.
- **Written questionnaires** can be answered incorrectly by employees who are afraid of losing their job or new hires in need of a job.

For a high-risk alert, the individual may need to take additional steps before receiving approval to return to work such as a 1:1 interview, additional screening, or more extensive measures.


